

## **Night We Light Parade Registration Form**

The First City of Lights Foundation invites your business or organization to celebrate 28 years of light and be part of the annual the Night We Light Parade on Friday, November 29, beginning at 6PM. The parade route will start at the Beltrami County Administrative Building parking lot (on the west side of the building) going east on 8<sup>th</sup> Street, turning south on Beltrami Ave. to 3<sup>rd</sup> Street where it will travel west and end at Irvine Ave. Please join us after the parade at the waterfront as we "flip the switch" to illuminate over a half million lights throughout the parks and downtown Bemidji to kick off the holiday season.

If your organization would like to participate, please fill out and send in the registration form by Friday, November 22. There is a \$30.00 registration fee for businesses; there is a \$15.00 fee for non-profit organizations. Pre-registration is required. If you do not pre-register you will be placed at the end of the parade line-up and charged a registration fee of \$40.00, non-profits will be charged \$25.00. Please make checks payable to the First City of Lights Foundation!

## **Parade Guidelines:**

- NO ONE is allowed to throw anything (candy, trinkets, samples, etc.) to the crowd from a moving vehicle. If you would like to hand out items to the crowd, please do so by walking.
- There is absolutely **NO CONFETTI ALLOWED**. Even if it is supposed to be dissolvable or biodegradable confetti. It is too cold this time of year and it does NOT dissolve in the snow.
- If you have horses or another type of animal in the parade, YOU are responsible for cleaning up after your animal(s) while the parade is setting up and in progress.
- Every parade unit must maintain three car lengths between you and the unit in front of you. Please remember that if you are walking in the parade that you must keep up with the motorized units. We do not recommend letting children walk in the parade unless their parent/guardian feels that they will be able to maintain the pace until the end.
- The parade will begin PROMPTLY at 6 PM. All motorized units should be in place by 5 PM. All walking units should be in place by 5:30 PM. To avoid delays, please allow enough time prior to these times to set-up your organization's parade entry.
- Check-in will begin at 4 PM near the Beltrami County Administrative Building in the parking lot that is located on Irvine Avenue between 7<sup>th</sup> and 8<sup>th</sup> Streets. All parade units need to check in by 5 PM and sign or turn in the enclosed Release/Hold Harmless form. If you do not check in, your spot will be given away.
- There is extremely limited parking. **NO PARKING** will be allowed in the Beltrami County Administrative Building west parking lot. All parking will be off-site on the surrounding streets, so we recommend that you carpool or have someone drop you off.
- **No live Santa Clause on your float!** Please respect that there will be one float with a live Santa Clause as to not confuse children.
- BE CREATIVE AND HAVE FUN!!!! Thank you for your participation and we look forward to having a great parade!
